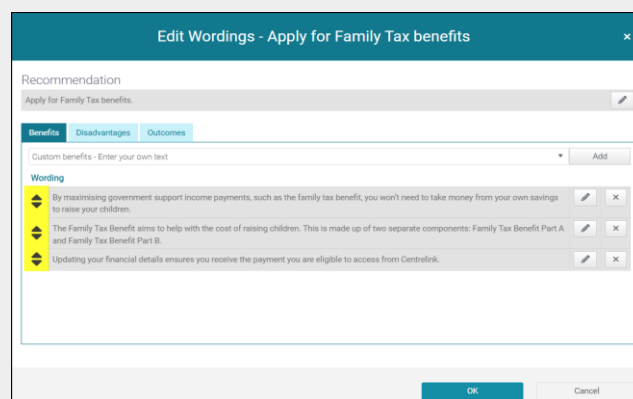
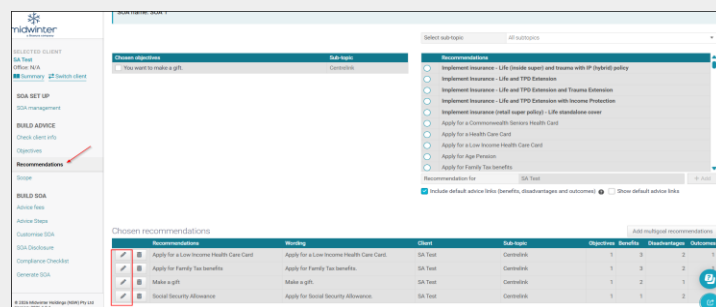
Ability to Re-order the Benefits/Disadvantages/Outcomes Within Planbuilder

Details: Planbuilder has been enhanced to allow advisers to easily re-order benefits, disadvantages, and outcomes within the Recommendations section.

Advisers can access this functionality by selecting the pencil icon on the chosen recommendation, then drag and drop individual rows to arrange content according to their preferences. This improvement helps reduce the time spent on formatting plans after the SOA is generated.

Improved AdviceOS Folder File Count Display

Module: Documents

Details: The file count view of the folders have been improved to provide a clearer and accurate file counts for the folders. When a top-level folder contains subfolders, the collapsed view now displays the total number of files across both the top folder and all its subfolders, ensuring files are visible at a glance without needing to expand the structure. When expanded, each folder (top-level and subfolders) shows its own direct file count.

File counts update dynamically as files are added, removed, or moved, reducing confusion and improving visibility when navigating folder hierarchies.

Updated Asset- Based Admin Fee Logic for Mercer Portfolios

Details: AdviceOS fee calculation logic has been enhanced to support Mercer's asset-based administration fees for blended investment portfolios, in line with Mercer's Product Disclosure Statement (PDS).

For Mercer Blended Investment Portfolios (Choice + SmartPath), administration fees are now capped based on the combined balance across Choice and SmartPath, with the cap applied only when the total balance exceeds \$500,000. The capped amount is allocated proportionally between Choice and SmartPath according to their respective balances, and fees are calculated on a pro-rata basis using the applicable fee percentages and cap values defined in the plan's fee schedule.

There are no changes to the fee calculation methodology for Mercer Single Investment Option portfolios.

Introducing Snapshot Functionality

Details: Introducing new functionality to further integrate Dynamic Fact Find with AdviceOS. After an adviser reviews and publishes a submitted fact find within DFF, a snapshot will be created within AOS under the relevant client.

By publishing the fact find the related fields in AOS will be automatically updated (current functionality) so the user does not need to navigate to AOS and then merge the snapshot. The purpose of this snapshot will be as a historical record of the changes made at that point in time, which a user can refer back to in the future.
